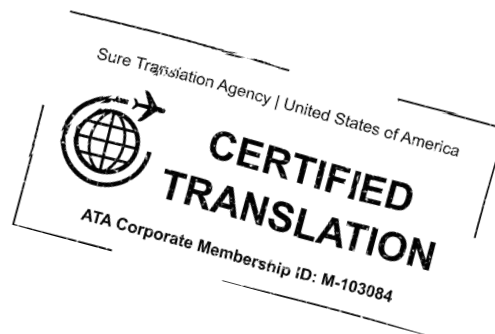

In the city of Cuilapa, department of Santa Rosa, on the third of October two thousand twenty-five, at eight hours and fifty-three minutes, present are Judge LUIS FERNANDO GONZALEZ TOSCANO; the representative of the Public Prosecutor's Office from the Prosecutor's Office against Human Trafficking, Assistant Prosecutor I Attorney FLOR DE MARIA SAENZ MONZON Y JORGE ANTONIO MARROQUIN SANTIZO; the representatives of the PGN OMAR DAVID CHIN ALVAREZ Y ARLIN MARISOL JIMENEZ MORALES; the judicial attorney-in-fact for the private prosecutor (complainant) JUAN RODRIGO MARIN FLORES; the accused NISSEN YEHOASHIA YEHUDA accompanied by his defense attorney CYNDI PAOLA MARIN HERNANDEZ; and the accused YOEL GOLDMAN and AVROHOM DINKEL accompanied by their defense attorneys ELIEZER NICOLAS BARRERA HERRERA and DARIO VASQUEZ PEREZ, for the purpose of holding the INTERMEDIATE PHASE hearing.

RULING: a) The indictment filed by the Public Prosecutor's Office is deemed amended as to the name of the Court to which it is addressed, the correct one being the Multi-member Court of First Instance for Criminal Matters, Drug Trafficking Activity and Crimes against the Environment of the department of Santa Rosa; b) The procedure is changed from the ordinary procedure to the abbreviated procedure, against NISSEN YEHOASHIA YEHUDA, YOEL GOLDMAN, and AVROHOM DINKEL for the crime of ABUSE AGAINST MINORS, accepting the facts; c) The proposed procedure is accepted and judgment is rendered: I) Messrs. NISSEN YEHOASHIA YEHUDA, YOEL GOLDMAN, and AVROHOM DINKEL are responsible as perpetrators of the crime of ABUSE AGAINST MINORS; II) For said offense, NISSEN YEHOASHIA YEHUDA, YOEL GOLDMAN, and AVROHOM DINKEL are sentenced to TWO years of imprisonment, commutable at the rate of five quetzales per day for each one; III) The accused are suspended of their political rights for the duration of the imposed sentence; IV) They are ordered to pay civil liability to the representative of the injured party in the amount of TEN THOUSAND UNITED STATES DOLLARS, at today's exchange rate according to the Bank of Guatemala of Q7.65919, within a period of two months; V) The consultation of procedural alternative outcomes by the Public Prosecutor's Office is taken into view and, since the requirements established by law are met, they are granted CONDITIONAL SUSPENSION OF THE EXECUTION OF THE SENTENCE only as to the principal penalty, not the accessory penalty, in favor of NISSEN YEHOASHIA YEHUDA, YOEL GOLDMAN, and AVROHOM DINKEL, under the following conditions: a) The term of the conditional suspension of execution of the sentence shall be for a period of two years; b) If during the time of the suspension they commit a new negligent offense, the benefit is revoked and they must serve the imposed sentence plus that of the new offense; c) Once the time of the imposed sentence has elapsed, it shall be deemed extinguished; VI) The accused are under substitute measures; they remain in the same legal situation, and once the judgment is final and the compensation is paid, the electronic monitoring device will be removed; VII) Notify and forward to the Execution Court as appropriate; d) The passports may be requested at the Public Prosecutor's Office, which has the authority to decide on their return. Everything that occurred in this hearing was recorded in audio, and they are duly notified. This proceeding ends in the same place and on the same date as its commencement, at nine hours and forty-nine minutes.-
