I address you for your knowledge and for the corresponding legal purposes, informing you that by resolution issued on this same date within the above-identified proceeding, the immediate arrest of the following person was ordered:

Person Subject to Arrest

ABRAHAN DINKEL a/k/a AVROHOM DINKEL, identified with passport number AS287519, whose residence has been listed as El Amatillo, Zone 0, Route Jalpatagua 9120, Municipality of Oratorio, Department of Santa Rosa, GPS latitude 14.174664, longitude -90.079612, or anywhere within the Republic of Guatemala.

The accused is charged with the offense of Mistreatment Against Minor Persons (Article 150 Bis of the Penal Code).

I respectfully address you for the purpose of informing you regarding the arrest of a person, as well as the forwarding of the technological devices found in that person's possession at the time of arrest.

Arrested Person

ABRAHAN DINKEL a/k/a AVROHOM DINKEL, 33 years old, born April 9, 1991, Canadian national, identified with passport number AS287519 issued by Canada.

At 11:25 a.m. inside the Migration Office of the Guatemalan Institute of Migration in Melchor de Mencos, Peten, the above-described individual was arrested by officers assigned to the International Police Division of INTERPOL Guatemala.

The individual was placed at the disposal of the Justice of the Peace Criminal Court of Melchor de Mencos, Peten, according to Police Prevention Report No. 03-2025 dated February 26, 2025.
